Jobscan Info Session

To increase access to resume related services, NCCU Law has launched a pilot partnership with JobScan, a company that offers Artificial Intelligence assistance with resume and cover letter review. They also offer reviews of a specific job description for compatibility with the users' resume and cover letter as well as LinkedIn optimization services.

To gain access to the JobScan system students must send an email to lawcareerservices@nccu.edu requesting access.

Details follow:

1. There is a cap on the number of student accounts
2. To allow as many students to access the JobScan as possible during this pilot phase, student access is limited to at most 2-months and access will not be renewed.
3. Note that due to the contract duration and when student users sign-up, some students will get less than 2-months of JobScan access
4. While students have an active JobScan account, there is no limit on the number of resume, cover letter, job descriptions reviews or LinkedIn services they can use
5. Access can only be granted using a student's official NCCU email address.

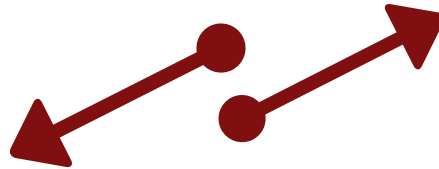
