# **Summer Funding Opportunities**

## The John Paul Stevens Fellowship

The Justice John Paul Stevens Public Interest Fellowship program was created in 1997 by former law clerks of Justice Stevens. The Stevens Fellowship Program honors the legacy of Justice John Paul Stevens, who served as an Associate Justice of the U.S. Supreme Court from 1975 until his retirement in 2010 and was actively involved in the work of the Foundation until his death in 2019.

All J.D. students enrolled as <u>1Ls or 2Ls</u> who will be working in an <u>unpaid full-time</u>, <u>public interest</u> <u>legal internship with a governmental agency or a nonprofit organization</u> for a <u>minimum of 10</u> <u>weeks</u> during the summer of 2021 are eligible to apply. The program will award **two** students **\$5,000 per student**. Students must submit all required materials by **Friday**, **March 31**, **2021 at 5pm**.

## **Public Interest and Judicial Internship Stipend**

This Public Interest and Judicial Internship Stipend provides **up to \$5,000 to 25 students** who have a <u>qualified, unpaid summer public interest or judicial internships or externships</u>. Current NCCU School of Law students (1L, 1E, 2L, 2E, and 3E) are eligible to apply. The application must be completed and submitted through Symplicity by **March 31, 2021 at 5PM**.

#### Qualifications

The student's public interest or judicial internships must be an unpaid internship or externship. If a student receives a partial payment from an employer, then the student will not qualify for the stipend. The general categories of potentially qualified internships include (not an exhaustive list): Legal Aid/Public Defender, Prosecutor (State or Federal), Government Agency (Local, State or Federal), Legislative (State or Federal), Judicial Trial Court (State or Federal), or Non-Profit Entities (must have a 501(c)(3) designation).

If you are unsure whether your internship qualifies, please contact the Office for Career and Professional Development.

### **Interviewing Resources**
