


Dean's Corner

- Be sure to log into Symplicity to view the list of employers:
- 1.Log in to the Symplicity dashboard
- 2.Select OCI
- 3. Click scheduling
- 4.Customize cover letters and save them under the employer's name for easy access to upload documents during the OCI bidding period.
- 5. Prior to bidding, be sure to research the employers, job description, hiring criteria, etc. this will prepare you to know which opportunities are the best fit to apply for once bidding opens.

SYMPLICITY

Symplicity is an online recruiting system that students and alumni can use to: apply to job postings, bid for on-campus interviews and resume collects, upload collateral documents (resume, cover letter, writing sample, etc.), request an appointment with a counselor.
