

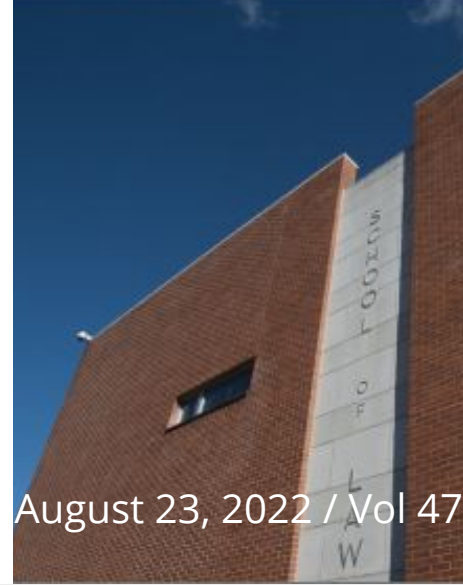

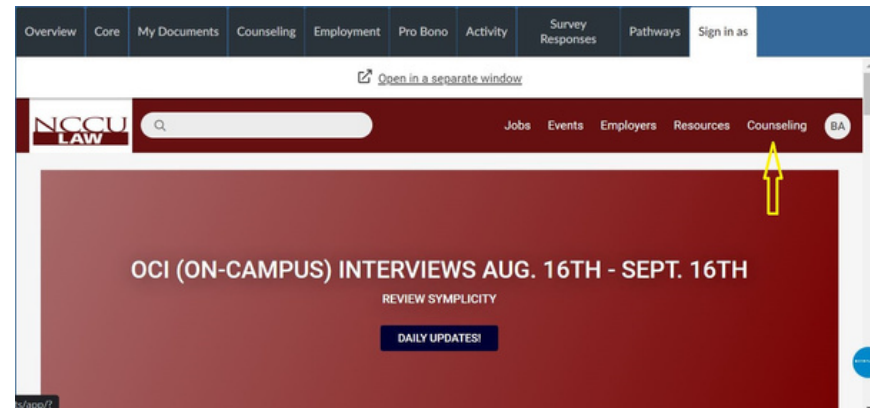

How to Request a Counseling Appointment

**** Attention 1L students, you will have access to make appointments via symplicity in October. However, you are free to stop by the office if you have any questions.****

1. [Go to: https://law-nccu-csm.symplicity.com/students/index.php?simplify_interface=1&signin_tab=0](https://law-nccu-csm.symplicity.com/students/index.php?simplify_interface=1&signin_tab=0)
2. Login to Symplicity with your student credentials. (student email address & password)
3. In the upper right-hand corner of the screen click, "Counseling," then "Request New Appointment" on the next screen.



4. Select the "type" of services you would like, and continue to select the parameters that fit your schedule, ex: date range, time range, location, counselor.
