

Alumna Regina Newell Stephens '87 Named EEOC's New Chief Administrative Judge

Congratulations to Legal Eagle Alumna Regina Newell Stephens on her appointment as the U.S. Equal Opportunity Commission's chief administrative judge in the Office of Field Programs.



Stephens, a graduate of NCCU School of Law and the University of North Carolina

at Chapel Hill began her career with the EEOC as an appellate attorney in Washington, D.C., where she worked in the Office of Review and Appeals, now the Office of Federal Operations. After several years in Washington, D.C., she returned to the Charlotte District Office as an administrative judge and was later promoted to supervisory administrative judge where she managed the federal sector hearings program for Virginia, North Carolina, and South Carolina. Before her selection, she was a member of the Office of Field Programs senior staff where she served as a National Hearings Program manager.

As chief administrative judge, Stephens will guide the program to accomplish its mission innovatively and equitably, with a particular emphasis on planning and policy development and determining program priorities and quality assurance.
