#### FAMILY LAW CLINIC - CLINIC CORNER

Anchored in Truth and Service. the Family Law Clinic has served countless underprivileged families in the areas of child custody. divorce, domestic violence and child support. This past semester has truly been a rollercoaster ride, but Clinical Director and Visiting Professor Katrina L. Smith is committed to producing practice-ready practitioners who are sensitive to addressing the needs of people and communities that are traditionally underserved and under-represented by the legal profession.

With Associate Dean Nakia C. Davis, Assistant Professor Dana "G." Jones, and Clinical Director/Supervising Attorney of the Juvenile Law Clinic Tenika R. Hall serving as mock judges, the Family Law Clinic students dissected a complicated legal fact pattern and conduct three mock trials in lieu of taking a final exam during the fall semester.

During Domestic Violence Awareness Month, students were afforded an opportunity to join Professor Smith at a Domestic Violence and Homeless Awareness Brunch sponsored by Jasmine's S.M.A.R.T. House in Raleigh, NC. The Awareness Brunch featured Drea Kelly, the ex-wife of R. Kelly, as the keynote speaker and Professor Smith provided the attendees with legal strategies on how to successfully obtain domestic violence protective orders. After the event, the students and Professor Smith participated in a private meet-and-greet with Ms. Kelly who expressed a sincere desire to partner with NCCU's Family Law Clinic on additional community-based initiatives in the near future.



In honor of National Homeless Youth Awareness Month, the Family Law Clinic and Professor Smith's Pleadings and Practice class partnered with Phi Alpha Delta International Law Fraternity and donated over 200 of the 400 cans that were provided to the

underserved families at the Durham Rescue Mission. This spring, the Family Law Clinic will be hosting free legal workshops and clinics with the Durham County Attorney's Office and Legal Aid of North Carolina to empower and equip community members on how to represent themselves in family court.


# Hometown/Undergraduate Insitution:
