DEAN EDWARDS NAMED TO 2023 LAWYERS OF COLOR POWERLIST

Dean Edwards was named to the Lawyers of Color's Power List 2023. The Lawyers of Color is a nonprofit organization dedicated to promoting diversity in the legal profession and advancing democracy and equality in marginalized communities. The power list recognizes the most influential minority attorneys and allies in the nation.

"I am honored to have received this distinction bestowed by the Lawyers of

Color Foundation," said Edwards. "As dean of the NCCU School of Law, I am dedicated to promoting a diverse and inclusive law school environment that pursues initiatives to increase access, admission, retention and graduation of leaders in the legal profession."

Edwards previously served as associate dean for faculty affairs and scholarly enrichment and John D. Fassett Professor of Law at NCCU School of Law. He is an interdisciplinary scholar whose work explores the use of social and systemic supports to understand racial disparities and to develop remedies to address these disparities. His scholarship includes law review articles, peer-reviewed journals, and book chapters that explore the use of social science evidence in equity contexts. Edwards connects his scholarship to his teaching of constitutional law, property, administrative law, and education law.

Edwards is committed to increasing minority representation in the legal profession through collaborations across NCCU's campus and among historically Black colleges and universities (HBCUs). He has been successful in gaining extramural funding to support NCCU School of Law's pipeline programs. As principal investigator, he helped NCCU become the first HBCU to receive a Law School Admission Council PLUS grant. Edwards has also worked with units across the university's campus on Title III and HBCU - Undergraduate Program (HBCU-UP) grants.

Edwards received a Ph.D. from the University of Pennsylvania's Graduate School of Education in the Education Policy Program and a J.D. from New York University School of Law.

"I believe the system that saw blacks as three fifths of a person at its foundation is the same system that treats us the same today," said Creft. "I believe the system is broken. I don't want to be an attorney to defend the law, I want to be an attorney to change it."

Creft serves as community service director for the Civil Rights Society and a 2L Student Bar Association Representative. She was recently elected as the new SBA president for 2023-24. "When it's our turn to leave the Nest, I want us to return and give back. The experience we have here at NCCU School of Law is the experience we will leave with." Upon graduation, Creft plans to pursue a career in civil rights public interest law, real estate and housing discrimination and consumer protection.

It is said that at the beginning of each academic year, Dr. James E. Shepard would tell students that "[t]he Eagle is no common, ordinary barnyard fowl [and] while a Sparrow clings to its flock, an Eagle soars alone." The Clinical Legal Education Program (CLEP) is committed to teaching students that practical skills training and experiential learning is vital to soaring. Our clinical directors and administrative staff work diligently to uphold the law school's mission to provide a practice-oriented legal education that is of quality.

Our curriculum provides a diverse body of clinical offerings which give our students opportunities to pursue justice for actual clients who are traditionally underserved and underrepresented by the legal profession. Students are able to apply what they have learned in their substantive courses to real world legal issues. Such practical experience is also advantageous during internships and externships and may provide a strong foundation as we transition to the NextGen bar examination.

On March 15, CLEP hosted a Clinic Fair for our students to introduce them to the "clinical experience," while enjoying great food, games and prizes. Students were also provided information on how our eight robust clinical offerings serve the community at large. Approximately 100 students attended the fair and a great time was had by all. We anticipate scheduling the Clinic Fair each spring semester before the registration period begins.
